

# Management provided (conservative)

- Topical silver sulfadiazine (omphalocele)
  - Vaseline (suspected bladder exstrophy)
  - Karyotyping (being processed)
- 
- Gain weight (6 kg)
  - Good passing stool
  - Good voiding
