The Glass Menagerie by Tennessee Williams and Riders to the Sea by John Millington Synge tell about Amanda and Maurya as widows that have conflict with their children. Amanda Wingfield as a widow has two children, Tom and Laura. Laura is a crippled girl and Amanda wants Laura to be an attractive girl and successful in career for the future in her life. Unfortunately, Laura does not obey her mother's instruction that makes Amanda disappointed. Meanwhile, in Riders to the Sea, Maurya has lost her beloved husband and sons in the sea.
