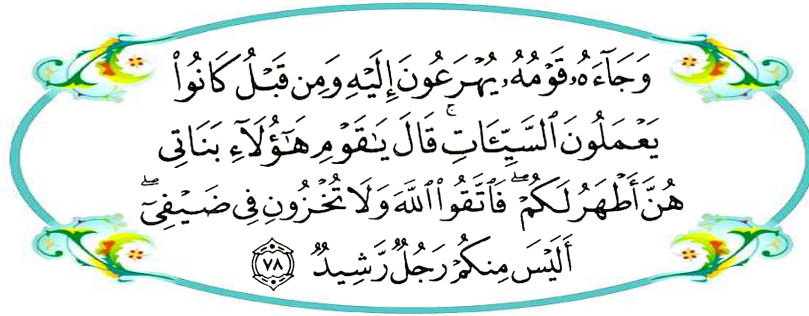

## ABSTRACT

*The Roman Spring of Mrs. Stone* is one of William's novels. It was published in 1950. Mostly, this novel tells about Mrs. Stone, the main character of this novel. In this novel, Mrs. Stone is identified as a popular actress who is much praised by her admirers. Meanwhile, when she fails to perform the role for Juliet character, her popularity get dimmed. She fails because she chooses the role that it is not suitable with her age in fifties. She stops her profession as an actress and goes to Rome. She uses her husband's illness as the reason of the journey. Actually, it is the tactic to avoid the shameful feeling after getting the failure in her performance. In Rome she does not free from problems even it leads her to new problems. In that country, she meets the young Paolo and falls in love with him. Unfortunately, Paolo does not seriously love her but he loves because of her wealth. Her unawareness to accept the reality that she is an old woman who must reduce her ambition, cause her tragic life on the progress life.
