



The Use of the Narrator's Language as Camouflage: A Study on Vladimir Nabokov's *Lolita*, Baiq irasti Melviana, 000110101049, 2006, 48 pages.

Nabokov's Lolita is a book that deals with obsessive lust and bloody violence, sex and murder often masked by the beauty of the language. One of the interesting things of the novel is the method of forcing the reader to understand the main character through a beautiful manipulation of language. The language in this novel is used not just merely to tell a story. It has another function. It is to camouflage the reader of the novel.

This thesis analyzes the words play and the intrigues that the main character use to camouflage his behavior and his crime. What makes the language used by the narrator affects the mind of the reader and why he uses the narrative style in writing his testimonial are the problems that will discussed in this thesis. The scope of this study is bound only in the structural analysis because it is an exploration about the literary elements that mainly build the novel. They are diction, imagery and point of view. Meanwhile there are two approaches used in this thesis, those are formalistic and psychological approach.

Language is very important in our live. When we meet someone for the first time, it is through language we usually guess the character of the person that we talked to. By the language that he uses we can get our first impression about him. The language in this thesis is analyzed from its diction, imagery and point of view. And it is more touching for him to write it in novel form than write it in a formal form of a testimonial so he can touch the reader's deep heart. He hopes the reader as the jury of his crime will not give their judgment objectively.
